CANCELLATIONS & REFUNDS: Cancellations must be received in writing. Cancellation fees are as follows:

- 1) Deposits are non-refundable;
- 2) cancellations received 61 days or more prior to the program start date, US\$500 per person;
- 3) cancellations received within 61 days of the program start date, 100% of the program cost.

ABOUT THE PROGRAM COST: The actual program cost is based on the US dollar rate of exchange at the time of costing, seven months prior to the program. Price is subject to change in the event of a rate of exchange change increase exceeding 5% & for unforeseen fuel surcharges. Enrollees will be duly advised about such a change in the program cost, should it be necessary.

ARRIVALS & DEPARTURES: The program begins & ends at the place and times stated on the program itinerary pages & in confirmation materials that will be mailed to you. In the event a participant is early or late at the arrival point and/or early or late leaving at the end of the program, she/he is responsible for arranging her/his own transfers & for any cost or expense thereof. Return flights from our final destination back to point of origin are specifically excluded in tour costs.
